

1. STANDARD TERMS AND CONDITIONS OF TRADE

1.1 In these terms and conditions the goods mean the goods as indicated on any company forms, price list, quotation orders, delivery notes or invoices.

2. PRICES AND QUOTATIONS

2.1 The price of the goods sold or services rendered shall be the usual price as set out in the SS Telecoms price list at the time of the sale of the goods.

2.2 SS Telecoms has the right to change the prices of the goods from time to time without prior notice to the customer.

2.3 All quotes remain valid for 3 (three) days from the quote date. The validity of any quote is subject to availability.

2.4 Unless otherwise expressly stated, prices are exclusive of value added tax, which shall be for the account of the customer.

3. PAYMENT

3.1 Payment is due immediately save for credit approved customers, in which event payment is due within the terms as specified in the client's credit agreement.

3.2 The customer has no right to withhold payment or make set offs or deductions from any payment due by it for any reason whatsoever. No extension of payment of any nature will be granted unless reduced to writing and signed by the customer and a duly authorised representative of SS Telecoms.

3.3 SS Telecoms shall have the right to suspend deliveries and to exercise its rights in terms of clause 4 if any amount due by the customer is unpaid.

3.4 If any amount owed is not settled in full (a) on the due date (b) on demand SS Telecoms is entitled to, without prejudice to any of its rights;

3.4.1 Immediately institute action against the customer and/or

3.4.2 Cancel the sale and take possession of any goods delivered to the customer, including goods sold or disposed of by the customer which have not been paid for in full and claim damages.

3.5 Should any amount not be paid by the customer on the due date, the full outstanding amount in respect of all purchases by the customer shall become due and payable, and the customer shall be liable to pay interest in

respect of an amount unpaid at the compound rate of 5% (five percent) above the prime overdraft rate of Standard Bank Limited on all overdue amounts from the due date until the date of payment, calculated and payable monthly in advance.

3.6 SS Telecoms reserves the right to suspend service and repairs of goods including warranty services to a customer if any amount due by the customer is unpaid or overdue.

4. WITHDRAWAL OF CREDIT FACILITIES

4.1 SS Telecoms' decision to grant credit facilities to the customer and the nature and extent thereof is at the discretion of SS Telecoms.

4.2 SS Telecoms reserves the right to withdraw, increase or decrease any credit facilities at any time without prior notice.

5. ORDERS

5.1 The customer hereby confirms that the goods and services on the tax invoice issued duly represent the goods and services ordered by the customer at the prices agreed to by the customer and where performance/ delivery has already taken place that the services and goods were inspected and that the customer is satisfied that these conform in all respects to the quality and quantity ordered and are free from any defects.

5.2 SS Telecoms will accept all written and verbal orders. All such orders and any variations to orders will be binding, subject to these standard terms and conditions and may not be varied or canceled without prior written consent from SS Telecoms. SS Telecoms will not be responsible for any errors or misunderstandings occasioned by the customer's failure to make the order in writing. SS Telecoms may require the customer to confirm verbal orders in writing before acceptance of such orders by SS Telecoms.

5.3 Orders shall constitute irrevocable offers to purchase the goods in question at the usual prices of SS Telecoms as at the date when the customer places the order of the goods, and shall be capable of acceptance by SS Telecoms by the delivery of the goods, written acceptance or confirmation of the order.

6. DELIVERY

6.1 Any delivery note (copy or original) signed by the customer and/or its authorised representative and/or its nominated agent and held by SS Telecoms, shall be prima facie proof that delivery was made to the customer.

6.2 SS Telecoms shall be entitled to split the delivery of the goods ordered in the quantities and on the dates it decides with the prior consent of the customer, which consent shall not be unreasonably withheld.

6.3 In the event of the customer choosing to engage its own third party to transport the goods, the customer indemnifies SS Telecoms against any claims of any nature that may arise from such an agreement.

6.4 SS Telecoms is entitled to engage a third party on its behalf to transport all goods purchased by the customer to the delivery address stipulated by the customer.

6.5 Should the customer wish to receive delivery of the goods by a more expensive method of transportation than that normally used by SS Telecoms, the customer shall make such request in writing and, in the event that SS Telecoms agrees to arrange such special delivery the additional charges shall be debited to the customer's account and shall be payable by the customer.

6.6 SS Telecoms does not guarantee that the goods will be dispatched or delivered on any particular date and time, and the customer shall have no claim against SS Telecoms in respect of any loss occasioned by any reasonable delay in dispatch or delivery of any goods ordered and/or services rendered, nor may the customer cancel any order by reason of such reasonable delay.

6.7 Short deliveries or goods damaged in transport must be reported to SS Telecoms head office within 24 (twenty four) hours of receipt.

6.8 All goods taken on an evaluation, approval or demonstration basis or all goods taken on consignment by the customer are deemed sold to the customer within 7 (seven) days of issue if not returned to SS Telecoms in a perfect condition in the original packaging and with all accessories and manuals intact.

6.9 SS Telecoms reserves the right to charge delivery charges, as and when necessary.

7. OWNERSHIP AND RISK

7.1 All risk in and to all goods sold by SS Telecoms to the customer shall pass to the customer on delivery thereof. Ownership in all goods sold and delivered shall remain vested in SS Telecoms until the full purchase price has been paid, and in the event of a breach of these terms and conditions by the customer, or if the customer is sequestrated or placed under liquidation or judicial management or commits any act of insolvency or enters into any compromise with its creditors or fails to satisfy a judgement granted against it within 7 (seven) days of the date of judgement or changes the structure of its ownership. SS Telecoms shall be entitled to take possession of the goods without prejudice to any further rights vested in SS Telecoms, and is hereby irrevocably authorised to enter upon the customer's premises to take possession of such goods without a court order.

7.2 Goods in the possession of the customer bearing SS Telecoms name, trademark, labels and/or serial numbers are deemed to be those for which payment has not yet been made, and should any breach of these terms occur, may be repossessed by SS Telecoms in terms of paragraph 7.1 above. The customer shall fully insure the goods purchased from SS Telecoms against loss or damage until the customer has paid the full purchase price for such goods. Pending payment to SS Telecoms for goods purchased, all benefits in terms of the insurance policy relating to the insurance of such goods, shall be ceded to SS Telecoms.

7.3 The customer shall inform the landlord of the premises at which the goods are kept that such goods are the sole and absolute property of SS Telecoms until such time as the customer has paid the full purchase price to SS Telecoms.

8. BREACH OF CONTRACT

8.1 In the event of a breach by the customer, should the customer fail to remedy such breach within 48 (forty-eight) hours after receipt of notice to that effect from SS Telecoms or should the customer repeatedly breach this agreement in such a manner that the customer's conduct is inconsistent with the intention or ability of the customer to carry out the terms of the agreement, or if the customer is sequestered or placed under liquidation or enters into judicial management or any act of insolvency or enters into a compromise with its creditors or fails to satisfy a judgement granted against it within 7 (seven) days of the date of judgement or change; the structure of its ownership. SS Telecoms shall be entitled without prejudice to its rights in law or in terms of this agreement to take possession of the goods and is hereby irrevocably authorised to enter upon the customer's premises to take delivery of such goods without court order.

9. LEGAL PROCEEDINGS

9.1 These terms and conditions shall be governed and constructed under and in accordance with the law of the Republic of South Africa.

9.2 SS Telecoms shall, at its option and notwithstanding that the amount of its claim or the nature of the relief sought exceeds the jurisdiction of the Magistrate's Court be entitled to institute action out of such court.

9.3 A certificate issued and signed by any director, member or manager of SS Telecoms whose authority need not be proved, in respect of any indebtedness of the customer to SS Telecoms or in respect of any other fact, including but without limiting the generality of the foregoing, the fact that such goods were sold and delivered, shall be prima facie proof of the customer's indebtedness to SS Telecoms and prima facie proof of delivery of the goods in terms of this contract.

9.4 A printout of computer evidence tendered by SS Telecoms shall be admissible evidence and the customer shall not be entitled to object to the admissibility of such evidence purely because such evidence is computer evidence.

9.5 The customer's address in the Distributor Application form shall be recognised as the customer's domicile for all purposes in terms of this contract whether in respect of the serving of any court process, notices that payment of any amount or communications of whatever nature.

9.6 In the event of the customer breaching any of its obligations and/or failing to make payment of any amount to SS Telecoms in time, the customer agrees to pay, and shall be liable to pay, all legal costs incurred by SS Telecoms in enforcing its rights in terms of these terms and conditions on the attorney/own client scale including collection charges, tracing agent's fees and air fares.

9.7 The customer agrees that neither SS Telecoms nor any of its employees will be liable for any negligent or innocent misrepresentations made to the customer, nor shall the customer be entitled to resile from these terms and conditions on those grounds.

10. ARBITRATION

10.1 SS Telecoms may refer any dispute arising from or in connection with this contract to arbitration which arbitration award shall be final and binding on the customer and SS Telecoms.

10.2 The arbitrator will be a person agreed upon by the parties or failing agreement, appointed by the Arbitration Foundations of Southern Africa, who shall then finally resolve the dispute or issue in accordance with the Rules of the Arbitration Foundation of SA.

11. RETURNED GOODS

11.1 Whilst SS Telecoms is under no obligation to accept the return of goods, the customer may apply to SS Telecoms for permission to return goods and if written permission is given - such goods must be returned to the offices of SS Telecoms at the customer's own cost.

11.2 The customers may return any defective goods to the premises of SS Telecoms or its nominee at the customer's own cost. SS Telecoms undertakes to replace such goods with items of the same or similar specification. No refunds will be considered in respect of the return of defective goods.

11.3 SS Telecoms reserves the right to offset the value of any goods accepted for return against any amounts due by the customer.

11.4 In the event of a cancellation of an order by the customer or goods accepted for return by SS Telecoms, SS Telecoms reserves the right to charge a handling fee on the value of the order canceled or goods returned.

12. WARRANTIES AND INDEMNITY

12.1 Goods may be guaranteed under the manufacturer's product specific warranties only, and all other guarantees and warranties including common law guarantees and warranties in relation to goods and services are hereby specifically excluded by SS Telecoms.

12.2 All guarantees are immediately null and void should any equipment be tampered with or should the "seals" on the equipment be broken by anyone other than SS Telecoms or its appointed nominee, or should the goods be operated outside the manufacturer's specifications.

12.3 To be valid, guarantee claims must be supported by the original tax invoice and the goods must be in their original packaging and must be accompanied by all accessories and manuals must be intact. All items must be returned in "new" condition.

12.4 No warranties whether express or implied shall apply, other than those provided in this contract. SS Telecoms specifically disclaims the implied warranty of merchantability and fitness for a particular purpose. No representation or warranty, including but not limited to statements of capacity, suitability for use or performance made by employees of SS Telecoms shall be considered to be a warranty by SS Telecoms.

13. REPAIRS

13.1 SS Telecoms liability in terms of a manufacturer's warranty is restricted to, in SS Telecoms or the manufacturer's discretion, the cost of repair or replacement of faulty goods or services or the granting of credit.

14. DISCLOSURE OF PERSONAL INFORMATION

14.1 The customer understands that the personal information given in the Distributor Application form may be used by SS Telecoms for the purposes of assessing credit worthiness.

14.2 SS Telecoms has the customer's consent at all times to contact and request information from any persons, credit bureau or businesses including those mentioned in the Distributor Application form and to obtain any information relevant to the customer's credit assessment, including but not limited to information regarding the amounts purchased from suppliers per month, length of time customer has dealt with each supplier; type of goods purchased and manner and time of payments.

14.3 The customer agrees and understands that information given in confidence to SS Telecoms by a third party to the customer will not be disclosed to the customer.

14.4 The customer hereby consents to and authorises SS Telecoms at all times to furnish credit information concerning the customers dealing with SS Telecoms to a credit bureau and to any third party seeking a trade reference regarding the customer in his dealings with SS Telecoms.

15.4 No relaxation or indulgence with SS Telecoms may grant the customer shall prejudice or be deemed to be a waiver of any SS Telecoms rights in terms of these terms and conditions.

15.5 The customer shall not cede its rights nor assign its obligations under these terms and conditions.

15.6 SS Telecoms shall at any time in its sole discretion be entitled to cede all or any of its rights in terms of this terms and conditions to any third party without prior notice to the customer.

15.7 The customer undertakes to notify SS Telecoms within 7 (seven) days of any change of address or change in member, director, shareholder, address or the information as set out in the Distributor Agreement.

15.8 The headings in this document (included for convenience) and are not to be taken into account for the purpose of interpreting this contract.

15.9 Each of the terms herein shall be separate and divisible terms and if any such term becomes unenforceable for any reason whatsoever, then that term shall be severable and shall not affect the validity of the other terms.

15.10 The customer undertakes to inform SS Telecoms in writing at least 14 (fourteen) days prior to the intended selling or alienating of the whole of or any part of the customer business and failure to do so will constitute a material breach of this contract entitling SS Telecoms to cancel the contract without further notice to the customer.

15.11. SS Telecoms follows radio emission regulations and do not take responsibility for any product being used outside of its intended use.
